XI. DISCUSSION ITEMS

- **a.** Student Senate Legacy Documents Handa (she/her) presented the Student Senate Legacy Documents and gave instructions on how to complete them.
- b. ACC and Religious Accommodations Neff (he/him) presented the work being done by ACC on the Religious Accommodations to get senate input on changes that may need to be made. Shorab (he/him) asked about religious holidays that have to do with the lunar cycles that a date cannot be provided at the beginning of the quarter. Neff responded that he would bring that to the ACC as a possible change. Handa (she/her) commented that "reasonable" accommodations is not defined.
- c. Theater Department Stambaugh (she/her) informed the senate that the theater department was planning to put on a play the next year, "No Exit" which was written in Nazi occupied France, that has a lot of sexist and homophobic undertones. The issue is being brought up to the department by the CFPA senators and students, so the senate is just being informed of the issue currently for awareness. Handa (she/her) asked how the plays are chosen. Stambaugh replied that she did not know the full process

beyond that students can submit ideas for the next year which are sometimes chosen from.
