## IV. COMMITTEE INFORMATION

## A. WSA Update

Stickney reported that McCardle was appointed Joint-Vice President for Recruitment and Retention. Galloway is running for Vice President for Legislative Affairs. The election will occur at the General Assembly in June. Stickney encouraged other committee members to run as well. McCardle listed off the remaining student positions: Vice President for Finance, Vice President for Communications, and President. Stickney directed the committee to the USSA document and asked the committee to read over it. Yau-Luu asked if the public service loan forgiveness mentioned in the Student Loan Forgiveness Act 2012 would change the other public service enacted in 2007. Stickney said that it moves the need of a ten year service down to a five year service. Brown agreed with the section on bankruptcy.
