## Constitution

#### **Preamble**

It will be the purpose of Russian Club to provide a place for students interested in Russian culture or language to practice, study, and share with each other.

#### Article I - Name

Section 1 The name of this organization will be Russian Club.

#### Article II - Membership

Section 1 Membership in this organization is open to all currently enrolled WWU students on a non-

discriminatory basis.

Section 2 If on multiple occasions a member is disrespectful and/or is a considerable hindrance to

the clubs goals they may be subject to termination of membership.

**Article III - Officers** 

Section 1 The officers of this organization will consist of President, Vice President, and Budget

Authority. Duties will be decided and assigned as needed during Officer meetings.

**Section 2** Officers must participate and be responsible in regards to the duties assigned to them.

Section B If an officer is not completing their duties and/or is not generally participating in the club

they may be terminated. This may be decided by the other officers or by club members.

**Article IV- Elections** 

Section 1 Election of officers will be held if a vacancy requires it. The election process will be

decided by acting President. If there is no acting President it will be decided by the

remaining officers.

**Article VI - Meetings** 

Section 1 Regular meetings will be scheduled weekly.

Section 2 Consensus Method will be used to decide the direction and activities of the club.

Discussion will be opened on each idea during regular meetings, discussion will be open to all members and each member will have the same amount of say in decision making.

This will happen during regular meetings.

Article VII - Advisers

Section 1 There shall be faculty/staff advisers who will be ex officio members with no voting

privileges.

Section 2 Advisers will be selected by the club officers, but may be recommended by any club

member.

### **Article VIII - Amendments**

Section 1 The constitution may be amended by a vote of over 60% of active club members. For

votes to count they must be present at the meeting in which an amendment is being

voted upon.
