DRAFT TBD Committee Charge & Charter May 2015

I. CHARGE

The TBD will evaluate the Associated Students of Western Washington University's structure. The goal of this committee is to understand why students don't get involved in the Associated Students, how we can create pipelines of opportunities for students to become leaders, increase student representation, ways to improve how the Associated Students tells the AS story and highlight the student experiences. This committee could consult with the SPAC and Budget Committee as they see necessary. The committee timeline would include three phases. The first phase is a learning phase in which committee members gauge student opinion and do research to further understand the AS structure. The second phase would be a synthesis phase, in which they could compile their information and analyze. The third phase would be the output phase in which they could bring an initial recommendation to the board. The committee will give updates to the ASWWU Board of Directors on progress with desired initial recommendation in Spring 2016.

HI. CHAIR The Chairperson shall be the ASWWU President or designee. The Chairperson

shall convene the meetings, approve agendas, and preside at all meetings. The Vice-Chairperson shall be ASWWU Vice President for Business and Operations

or designee and acts in the absence of the Chairperson.

IV. MEETINGSMeetings shall be called by the Chair. The committee shall meet once a week

with a minimum of twenty four (24) hours notice. Meetings may also be called by any member with support of at least twenty-five (25%) of the seated, voting

membership.

V. VOTING In order for a motion to pass, it must obtain a majority of the legal votes cast.

An abstention shall not count as a legal vote cast.

VI. QUORUM A majority of the voting membership shall constitute a quorum. If a quorum is

not present, the Chair will adjourn the meeting and reschedule to a new day and

hour.

VII. SUBCOMMITTEES In order to provide for coordination and direction, the committee may establish

subcommittees as necessary. Unless otherwise noted, these groups shall follow

the provisions of the committee with respect to procedure.

VIH. RULES The committee may adopt and amend rules of operation governing its
