Elections Board Charge and Charter September 2015 August 2011

L. Charge:

<u>Make</u> decisions concerning the fairness of Associated Students Election proceedings through hearings regarding candidate grievances. Judgments shall be made according to the Election Board's interpretation of the rules and regulations outlined in the AS Election Code.

**II.** Membership:. » Chair shall be hired by the AS Personnel Office by the first week of

winter quarter and shall not be an AS employee, candidate, or involved with a candidate's campaign.

- Twelve (12) students-at-large, no more than two (2) from any one Western affiliated organization or club, to be appointed by the AS Board of Directors.
- Advisor (non-voting).

No Election Board member shall be a candidate, or involved with candidate's campaign.

III.C hair:

<u>The Chair shall</u> be hired by the AS Personnel Office. They shall convene meetings, approve agendas, preside at all meetings and report all actions taken to the AS Board of Directors.

**ΓΥ.** Meetings:

^Meetings shall be called by the Chair as set forth by the Election Code. If more than one grievance is filed, they will be heard in the order in which they were received by the Chair. The proceedings shall follow the rules and regulations as stated in the AS Election Code.

**Appointments** 

Appointments made by the AS Board of Directors cannot be rescinded or changed after the official election process has begun, unless approved by a majority vote of the AS Board of Directors.

V. Voting:

<u>Jn order</u> for a motion to pass, it must obtain a majority of the <u>legal</u> votes cast. An abstention shall not count as a <u>legal</u> vote cast.

VI. .Quo rum:

Jive members, including the chair shall constitute quorum. Each party to a grievance is allowed to disqualify one member from serving on the hearing panel. The chair cannot be disqualified. Of the twelve (12) students at-large, four (4) will be selected.
