Abby Ramos, A.S. Vice President for Diversity, called the meeting to order at 5:02p.m. on Tuesday, November $3^{\text {rd }}, 2015$.

## I. REVISIONS TO THE AGENDA

Ramos said that she was adding discussion on Ryan Robert's membership on the committee. She reminded the committee how to fill out a budget request form. She expressed that forms should be made viewed instead of private so that she would be able to view them as well.
II. INFORMATION ITEMS
a. VSA (\$1050)

A Guest from VSA that their club was going to a conference in Oregon. They said that the request was transportation and lodging. They said that lodging would cost $\$ 750$ for the hotel rooms necessary to house the participants and $\$ 100$ per car they were planning to drive down. He said that the conference provided two meals for the group. Ramos asked how much registration was. He said that registration originally cost $\$ 30$, but was now up to $\$ 45$. Lee asked how many cars they planned on taking. The guest answered three at $\$ 100$ per car. Cha asked if they were also planning a heritage dinner. The guest said they plan to have enough funds to do both. Liang asked how many participants were going to the conference. The guest answer twelve. Ramos asked how the club was decided who got to go to the conference. The guest said that officers were selecting participants based on interest level. Ramos asked is they had an application process. The guest answered that they did not think an application was necessary because they planned on being able to bring everyone who showed interest. Moreno asked for VSA to update the committee on the process they planned to use for selection of participants.
b. SASA $(\$ 1065)$

Realia Harris said that SASA was planning on having an event for Diwali. She described the event as a huge holiday celebrated mostly in India. She said that they were requesting money for food, advertising and miscellaneous items such as decorations and henna. She said that they hoped not to charge an admission fee, but wanted to have a donation box. She said that $\$ 1000$ was a lot of money and specified that if SASA had a heritage dinner that they planned on collaborating with Students for Sustainable Food. Ramos asked when the event was. Harris answered November $21^{\text {st. }}$. Ramos asked if they had enough time to advertise. Harris said yes and that word of mouth can spread quickly and henna was a huge bonus for guests. Ramos said that it was too late to use the publicity center for promotion. Sanchez said that they had done advertising through Office Depot and Whatcom. Flanagan asked if this event was a substitute for a heritage dinner. Harris said that they were planning a smaller heritage dinner for later in the year and that the dinner would be dependent on a partnership with another club like Students for Sustainable Food. She stressed that they wanted to put the focus on this event. Moreno asked if they were doing catering through Aramark. Harris said that she had looked into it, but could not put in a request until Steering Committee funding was approved.

c. WHSA (\$205)

Lee said that WHSA had been around two years, but this would be the this year for the event. She said that they were planning on doing a College Night. She said that WHSA alone was producing the workshops and handouts. She said that the request was for food, transportation, and printing. She estimated about 45 attendees. She said that workshops would describe how to apply for college, scholarships, and financial aid as well as resumes and cover letters. She said although the main target of the event was the Hmong community that the event was open to all. She said that the goal of the event was to encourage potential students of the Hmong community to apply for college and provide them with tools to do so. Cha asked about food for the event. Lee said that they had planned on ordering pizza because it was easy and fast. Ramos recommended having other options. Sanchez asked where the event was being held. Lee said that that the event would be held at the Kirkland Heights apartment complex. She explained that they need funds for transportation to be able to get to Kirkland. Flanagan how they planned to advertise. Lee explained that they planned to advertise at Hmong New Years in Seattle wherer there would be over a thousand people as well as reaching out to Hmong youth groups. Cha asked about the drivers. Lee said that one was not, but that that driver was a volunteer through the ESC. Panelo asked what the date of the event was. Lee said they planned for Saturday November $21^{\text {st }}$ from $4-8 \mathrm{pm}$. Moreno asked if the request needed a buffer incase gas was more expensive than estimated. Lee explained that they were requesting ten extra dollars as a buffer and asking for the request to be an underwrite so that extra funds would come back to the committee. Navarre asked about the raffle portion of the event. Lee explained that they had already received funds from Activities Council to put on a raffle at the event. She explained the raffle was to encourage more people to turn out and that the raffle would be free.

d. $\mathrm{ACC}(\$ 200)$

Knutzen said that ACC was hosting a Thanksgiving dinner for the African Caribbean Community parents and kids. She explained that turkey would cost $\$ 90$, premade from Costco, food like potatoes and stuffing would be $\$ 30$, drinks would be $\$ 20$, plates and utensils would be $\$ 20$, and decorations would be $\$ 30$ for a total of $\$ 200$. She estimated about 50 people at the event. She said that the event was planned for November $21^{\text {st }}$. She explained the event was mainly for adopted children so they planned on having games and they had already contacted those attending. Ramos asked where the event would take place. Knutzen said that they planned to have the event in a room on the $4^{\text {th }}$ floor of the VU. Panelo said that if the turkey was from Costco that the order would need to be a reimbursement because the committee did not have a purchasing order with Costco. He mentioned that they did have a purchasing order with Fred Meyer. Sanchez said that he had time to look into pricing. Khuu asked if $\$ 200$ was enough funding for the event. Knutzen said that they were asking participants to bring other food as a potluck as well. Nguyen asked if this was the first year to host such an event. Knutzen said that this was the first year. Nguyen asked how they decided to host this event. Knutzen said that ACC wanted to connect with their community and remind the kids invited to the event that they have cultural support. Roberts asked if they investigated university policies on potlucks. Panelo said that the majority of food needed to be from the community. He also said that the group could not cook inside of the building.

## III. Update on ESC Renovation

Ramos said that the next day there was going to be a last minute meeting at 10:30am and 11:15am in the Bookstore and ESC respectively. She said that those meetings were a chance to talk about the Bookstore square footage and know what the ESC needs. She expressed that this was a chance to discuss what the ESC needs in terms of location and space.

She said that that evening at 8 pm there would be a photo taken of the ESC demonstrating how many students actually fit in the ESC. She emphasized that they needed as many people as possible. Panelo added that in the next weeks they would be talking to a task force. He said that they would
be inviting the community of Western into the conversation. He said that the Facebook page would be public the following day.

Ramos explained that voting membership in Steering Committee included all Steering Reps and that herself and Nate Panelo did not have voting rights. She said that Roberts, the Club Business Director, did not have a vote. Roberts said he was impartial, but noted that he gets a vote on Activities Council. He expressed that having a vote on the committee would make him feel more involved, but that he understood if he did not receive a vote. He said that he felt as though he had an intimate understanding of budgeting and came to the committee with a unique perspective. Harris said she felt that Roberts' was involved even though he did not vote. Lee asked if the conversation could be tabled for the next meeting to give them time to think about the topic. She also expressed an appreciation for Roberts' opinions. Cha asked if they would need to change the Charge and Charter if Roberts gained a vote. Ramos said yes and that a new Charge and Charter would need to be approved by both Steering Committee and the Board of Directors. Moreno asked why Roberts had a vote on Activities Council. Panelo said that it was really up to the particular council or committee on voting. Roberts said his position was originally an assistant and now the position has changed to $a$ director and that changed his positions vote on Activities Council.

Ramos mentioned that the next day at $8: 30 \mathrm{am}$ there would be a meeting about search for a university President on the $6^{\text {th }}$ floor of the VU. She said that it was meant for students to express their opinions and share a voice.

KSA- Cha said that they had elected two freshman officers.
MEChA- Sanchez said that they had elected officers and that Dia de los Muertos went well. He said that their regional monthly meeting in Yakima.
