IV. INFO ITEMS

a. Jesse Moore Funding Request.

Guest Karen Stout attended this meeting in order to explain the funding request for funds to bring Jesse Moore to campus. They want to bring Moore for a full week, as he was here briefly last year, but want him to engage with as many students as possible this time around. He has only been graduated for about ten years, so he can potentially give more relevant advice and have more engaging conversations with students. They are having him come to campus April 22nd through the 26th, and they are currently developing the schedule – currently, they have him down for speaking with some of the local high schools, meeting with BSU, and the "Courageous Conversations" on that Wednesday night.

Hessami gave some context that this was brought to the Board as a funding request but Hessami thought it would be more appropriate to come to LAC. Hessami said that she would be comfortable with around \$500-\$750. Regardless, Stout would like LAC's help with developing programs and events for Moore.

Hessami said that she would like Moore to be able to meet as many students as possible. Harren suggested having some sort of career-centered event. Schorr suggested working with the Herschel Research and Writing Studio for an event like that.
