STEP 1

FIRST EOO CONTACT

THE PROCESS BEGINS WHEN YOU GO TO THE EQUAL OPPORTUNITY OFFICE, LOCATED IN OLD MAIN 345. FROM THERE, YOU HAVE TWO OPTIONS. YOU CAN CHOOSE TO...

FILE AN INFORMAL COMPLAINT. THE EOO
WILL MEET SEPARATELY WITH INVOLVED
PARTIES AND THE ISSUE WILL BE RESOLVED
THROUGH "NEGOTIATION, MEDIATION, AND
CONFLICT RESOLUTION TECHNIQUES". THIS
DOES NOT ASSESS IF DISCRIMINATION HAS
OCCURED. NOTE THAT NO FORMAL ACTIONS
CAN BE TAKEN FROM INFORMAL

PROCEEDINGS. IF THE OUTCOME OF THIS
PROCESS IS UNSATISFACTORY, OR IF YOU'RE
WILLING TO INVEST IN A MORE LENGTHY
LEGAL PROCESS, YOU CAN...



THE EOO WILL THEN NOTIFY THE RESPONDENT, AND SET UP AN INPERSON MEETING IN WHICH THE ALLIGATIONS WILL BE DISCUSSED. THE RESPONDENT WILL SEE THE STATEMENT THAT YOU GAVE, AND BE ENCOURAGED TO WRITE A WRITTEN RESPONSE WITHIN TEN DAYS. THE PROCEEDINGS WILL CONTINUE EVEN IF THEY DECIDE NOT TO PARTICIPATE.

SANCTIONS

AFTER THE INVESTIGATION. THE STUDENT CONDUCT OFFICER MICHAEL SLEDGE (IN THE CASE THE RESPONDENT IS A STUDENT), OR THE VP OF ACADEMIC AFFAIRS BRENT CARBAJAL (IN THE CASE THAT THE RESPONDENT IS A WWU EMPLOYEE) WILL DETERMINE APPROPRIATE ACTION IN RESPONSE TO THE FINDINGS. POSSIBLE SANCTION INCLUDE (FOR STUDENTS): TRAININGS. WRITTEN EDUCATIONAL PAPERS. NO TRESSPASS/CONTACT ORDER. TERMINATION OF CAMPUS HOUSING, SUSPENSION OR EXPULSION FROM WWU. SANCTIONS FOR EMPLOYEES MAY RANGE FROM TRAININGS. LETTERS OF REPRIMAND. DEMOTIONS, POSTPONEMENT OF LEAVES OR SALARY INCREASES TO FULL OR PARTIAL SUSPENSION. OR TERMINATION OF EMPLOYMENT.

STEP 2

FILE A FORMAL COMPLAINT

FILE A FORMAL COMPLAINT WITH THE EOO. YOU WILL MEET WITH AN EOO VESTIGATOR AND PROVIDE A FORMAL STATEMENT. INCLUDING THE NAMES OF POSSIBLE WITNESSES. THIS PROCESS INVOLVES FILLING OUT A COMPLAINT FORM. WHICH MUST INCLUDE THE NAME OF THE RESPONDENT. IN TEN DAYS, THE VP OF THE EOO. SUE GEUNTER-SCHLESINGER. WILL DECIDE WHETHER YOUR COMPLAINT FALLS UNDER THE JURISDICTION OF THE EOO AND WHETHER THERE IS ENOUGH EVIDENCE TO CONDUCT AN INVESTIGATION. IF DENIED. YOU CAN FILE AGAIN OR GO TO ANOTHER SOURCE OUTSIDE WESTERN WASHINGTON UNIVERSITY.

STEP 4

THE INVESTIGATION

WITHIN 60 WORKING DAYS
OF THE FILING DATE, THE
EOO WILL BEGIN AN
INVESTIGATION. A REPORT
WILL BE WRITTEN AND
GIVEN TO BOTH YOU AND
THE RESPONDENT

ADDITIONAL INFORMATION

IF A STUDENT DOESN'T WISH TO FILE A COMPLAINT, THE UNIVERSITY ADMIN OR THE EOO CAN FILE ONE IN THEIR PLACE. THE NAMES OF INDIVIDUALS IN THIS DOCUMENT ARE SPECIFIC TO WESTERN WASHINGTON UNIVERSITY THE ROUGH TIMELINE GIVEN IN THIS DOCUMENT MAY BE LONGER DEPENDING ON MULTIPLE FACTORS A FULL VERSION OF THE DISCRIMINATION COMPLAINT PROCEDURE FOR WWU CAN BE FOUND TINYURL.COM/Y5GBU2LS
