IV. Action Items

A. LAC Proposal- Student Support Package

- 1. This legislative priority would devote \$200,000 per biennium for the Veteran Services Center, \$200,000 for a new CASAS employee, and \$200,000 for the Counseling Center.
- 2. In the past, the funding for the Counseling Center had been questioned because the LAC was under the impression that funding would go to creating a counseling alternative in the MCC that was student-run. Dreschel had a meeting with Sislena Ledbetter to clear this up, and there is no plan for this to happen, but instead set up a similar area with trained counselors or at the very least grad students, which does not have a defined space as of yet. Ledbetter is working on making wellness on campus a comprehensive system, collaborating with students, and AS Board members have also expressed interest in working on this.

V. Information Items

- A. LAC Proposal- K-12 Civics Education
 - 1. The AS has a history of advocating for K-12 issues. Currently there is testing for civics but no credit devoted to civics, and no curriculum in any social studies class set aside for civics either. Legislators cannot add more credits high school graduation requirements, because it would make it impossible for students to graduate on time if they failed even one class. However, this proposal does advocate for expanding programs that get high school students involved with the state legislative system.
