## **ASWWU Resolution on Tuition and Fee Revisions as Response to COVID-19 Pandemic.**

WHEREAS, the World Health Organization has classified the COVID-19 outbreak as a worldwide pandemic;<sup>1</sup> and

WHEREAS, Western Washington University has suspended all in-person courses for all of Spring Quarter 2020; <sup>2</sup> and

WHEREAS, Western Washington University, and other relevant agencies, have taken actions to assist students during this pandemic; <sup>2</sup> and

WHEREAS, the actions taken by the university are helpful and appreciated, but far from adequate; and

WHEREAS, there are two student-led petitions calling for Western Washington University to reduce the overall cost of tuition and fees which had amassed 5,671 at the submission of this resolution; <sup>3,4</sup> and

WHEREAS, students and their families may not be financially stable during the current socio-economic climate; <sup>5,6</sup> and

WHEREAS, Western Washington University has said that it will not be lowering tuition charges for spring quarter 2020; <sup>7</sup> and

WHEREAS, a week of instruction for Spring 2020 was cancelled; <sup>7</sup> and

WHEREAS, instructors only had 24 days of notice to move all of their curriculum online and the UFWW has stated that this shift will lead to “a compromised educational experience”; <sup>7,8</sup> and

WHEREAS, campus buildings that students are required to pay maintenance and operation fees for are closed to them including, but not limited to, the Non-Academic Building Fee, the Student Recreation Fee, the Service & Activity Fee and the Multicultural Center Fee; <sup>7,9</sup> and

WHEREAS, many students rely on jobs in the service industry as a source of income; and

WHEREAS, almost all RA's and apartment advisers were laid off and they have expressed concerns about finding housing, food, and safety; <sup>10</sup> and

WHEREAS, the National Association of Graduate-Professional Students (NAGPS) has released a statement calling for education institutions to offer at risk students tuition reductions or waivers

BE IT RESOLVED BY THE ASSOCIATED STUDENTS STUDENT SENATE WESTERN WASHINGTON UNIVERSITY:

THAT, the Western Washington University's Board of Trustees (WWU BoT) shall refund overall tuition statements for Spring Quarter 2020 by 12.9%; and

THAT, the WWU BoT shall refund students for the maintenance and operation of building fees that they do not have access to; and

THAT, the WWU BoT shall extend the tuition payment deadline for Spring Quarter 2020 to the fifth Friday of the quarter (May 8); and

THAT, the WWU BoT shall exempt late tuition payment fees and interest assessment for Spring Quarter 2020; and

THAT, the WWU Registrar's office shall exempt late add/withdrawal fees for Spring Quarter 2020; and

THAT, the Western Washington University Food and Housing Services (WWU FHS) shall extend the payment deadline for Spring Quarter 2020 to the fifth Friday of the quarter (May 8); and

THAT, the WWU FHS shall exempt late payment fees for Spring Quarter 2020; and

THAT, the WWU FHS shall halt the following actions due to late payments for Spring Quarter 2020:

Suspension of Student Dining Accounts;

The termination of Housing Agreements; and

THAT, WWU FHS provide free housing and meal plans to the students that they laid off for Spring Quarter 2020; and

THAT, all students with on-campus hourly jobs shall receive compensation, for the duration of Spring Quarter 2020, for work as if they had continued to work the same hours during Spring Quarter 2020; and

THAT, WWU shall grant all work-study students their full work-study allotment; and

THAT, WWU shall instruct professors and TAs to provide a recorded version of lectures and sections for all students during Spring Quarter 2020; and

THAT, WWU shall instruct professors and TAs to allow for a 12 hour grace period on assignment deadlines for all students during the first week of Spring Quarter 2020; and

THAT, WWU, the WWU FHS, the WWU's Department Chairs, and other relevant agencies, shall increase their transparency, currently and in the future, regarding immediate and impactful decisions resulting from Natural Disasters; and

THAT, this resolution be forwarded to President Sabah Randhawa, Vice President Melynda Huskey, Provost and Vice President Brent Carbajal, Vice President Stephanie Bowers, Vice President Richard Van Den Hul, Vice President Donna Gibbs, Vice Provost Steven Vanderstaay, Assistant Dean Michael Sledge, WWU Board of Trustees, and all WWU Deans.

## **ASSWWU on Reasonable Accommodations and Asynchronous Course Instruction Amid COVID-19 Pandemic.**

WHEREAS On 13 March 2020, Governor Jay Inslee issued Proclamation 20-12, which prohibits all public and private universities, colleges, etc., from conducting in-person classroom instruction and lectures,” in effect from 12:01 a.m. on 17 March 2020 until 12:00 p.m. on 24 April, 2020;<sup>2</sup>

WHEREAS On 19 March 2020, Western Washington University President Sabah Randhawa announced that “all classes and instruction will be offered remotely throughout spring quarter on our main campus, and at all centers, facilities and operations statewide.”;<sup>3</sup>

WHEREAS On 16 March 2020, the Imperial College COVID-19 Response Team published a report recommending that our present condition of population-wide social distancing (combined with home isolation of cases and school and university closure) be sustained for upwards of 18 months -- at least until a safe and reliable vaccine is readily accessible to the general public;<sup>4</sup>

WHEREAS As of the start of spring quarter, 6 April 2020, faculty have had 12 calendar days (from Governor Inslee’s Proclamation 20-12)<sup>1</sup> to at least partially adapt their courses to online teaching and learning and 12 calendar days (from President Randhawa’s March 13<sup>th</sup> Coronavirus Update) to make the full conversion<sup>4</sup>;

WHEREAS There is no university directive mandating that lectures, quiz sections, lab sections, seminars, etc. be accessible asynchronously;

WHEREAS Requiring synchronous participation in lectures, quiz sections, labs, seminars, etc. disadvantages:

1. Students who do not reside within the Pacific Standard Time (PST) Zone -- namely out-of-state students and international students;
2. Students who do not have reliable and consistent access to the internet and/or the equipment needed to participate in instruction at the time that it is provided;
  - a. Students do not have access to free WiFi hotspots at local businesses or the ability to rent WiFi hotspots from Western Washington University.<sup>5</sup>
3. Students who are affected by COVID-19 directly. For example:
  - a. Students who are currently afflicted by Covid-19 and do not have the capacity to participate in synchronous instruction due to general symptoms or hospitalization;
  - b. Students who need to care for loved ones afflicted by Covid-19;

- c. Students whose mental health has been impacted by Covid-19;
- 4. Students whose learning styles don't necessarily translate well to online learning; those who may benefit greatly from reviewing lectures, quiz sections, labs, seminars, etc.  
(add students with disabilities under #4 and their barriers with online learning?)

THEREFORE, BE IT RESOLVED BY THE ASSOCIATED STUDENTS OF WESTERN WASHINGTON UNIVERSITY

THAT The administration issue a directive mandating asynchronous access for all online instruction, including, but not limited to: lectures, quiz sections, and lab sections;

THAT If the directive cannot be complied with while maintaining the integrity of a course, 1) WWU faculty instructing the course must provide adequate justification as to why through a process defined by the administration, and 2) faculty must reasonably accommodate students who do not have synchronous access to instruction for any reason;

THAT According to the Office of the University Registrar, “‘reasonably accommodate’ is defined as coordinating with the student on scheduling examinations or other activities necessary for completion of the program and includes rescheduling examinations or activities or offering different times for examinations or activities”;<sup>5</sup>

THAT the ASWWU condemns any party or parties (courses, programs, departments, etc.) directing students to alter their course schedule because asynchronous access and/or reasonable accommodations allegedly cannot be provided;

THAT, this resolution be forwarded to President Sabah Randhawa, Vice President Melynda Huskey, Provost and Vice President Brent Carbajal, Vice President Stephanie Bowers, Vice President Richard Van Den Hul, Vice President Donna Gibbs, Vice Provost Steven Vanderstaay, Assistant Dean Michael Sledge, WWU Board of Trustees, and all WWU Deans.
