- b. Handa reported that there were concerns about the op-ed released by the dean and issues with it threatening BIPOC student safety in the crossfire and she also attended the meeting to discuss the issues and also met with WWU's president about the topic. A resolution will be written with the ASVP of Governmental Affairs to reaffirm the BSO Demand on the topic of the name change for the College of the Environment.
