VII. Officer Reports

AS President: Handa reported that she is working to find out if WWU can host the Washington Student Association General Assembly. Handa said that the owner of Sweet Bellingham in Fairhaven has been accused of sexual misconduct with employees and not requiring food handler's permits. Sweet Bellingham tables at WWU, and students have asked that he is no longer allowed to. Schexnayder said that it was an issue that

the Student Union Advisory Group would work on when they are more established.

ASVP for Governmental Affairs: Resendiz-Eyler reported that he has been working with Teagan Hudson on Local Lobby Day. The Board discussed the membership of the Active Transportation Advisory Committee.

ASVP for Activities: Schexnayder reported that he has been working on the Activities Council Charge and Charter. SPC voted to hire a new editor in chief for one of their publications. The Student Union Advisory Group met, and they are onboarding student members. He has been working with WAWU to support them.

ASVP for Diversity: Boliy reported that they have been working with the MCC, focusing on streamlining communications between the AS and the ADEI Units. She has also been meeting with Students Demand Action because they want to lobby.

ASVP for Student Services: Snyder reported that she has been appointing people for University committees. She has been looking at the ATA Charter. The Board discussed the number of Executive Board members on the committee.

ASVP for Sustainability: Seb Genge reported that interviews had started for a new SEJF Student Ambassador. They have their final candidates. SEJF has been going well. They have been reviewing Grant Applications. The Presidents Sustainability Council met the previous week, and progress has been slow. The Sustainability Action Plan document is being drafted.

At-Large Senator: Gabe Wong reported that the Senate passed the Ramadan Resolution. They have been working on the Arbitrary Borders art project with the Western Gallery.
