b. **WWU CWMEA \$3765**

Lucas Webster, CWMEA president, and Mia Lapingcao, secretary, request travel funds for CWMEA to go to Yakima. The \$3765 would be to pay for a bus rental for faculty and students to travel together to the Yakima, WA state music educator's conference. This event would be open to all students if they apply. Everything else requiring funds will be paid for through the music education department. The registration costs will be \$65 per student unless the student cannot afford it then the club can step in to pay. Ryan says that the request of \$3765 is too much for this quarter but that the council will pay for part of \$3765 this quarter with the rest being brought to the council throughout the next quarters. Ryan says that this will be moved to an action item next week.

c. Financial Management Association \$750 for entire year

i Devin Moreno, treasurer, asks for \$750: \$500 for pizza, \$50 for supplies, and \$200 for fundraising materials. The FMA recently received a \$200 donation anonymously and is expecting \$120 from last year's College of Business and Economics spring gala. Ryan denies request for \$500 for pizza but says that the \$250 would be able to be given. Moreno says that the club will require its members to pay \$30 as dues with multiple tiers. The council asks why the club is having their members pay dues when students are already asked to pay club fees. Moreno says that paying dues will allow members access to club resources and connections so you can't be an official member of the club unless you pay dues.
